RESOLUTION AND ORDER

On July 30, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("July 30 Resolution") granting NFE POWER PR, LLC ("NFE POWER") fifteen (15) days: (i) to submit the information and credentials of the entity or entities contracted, indicated in its 2025 *Operational Report for Electric Service Companies* (Form NEPR-B03), and (ii) to describe what services, equipment, and systems the contracted they will operate.

On August 1, 2025, NFE POWER filed a document titled *Request for Extension of Time to Submit Financial Statement* ("August 1 Motion"), requesting an extension until October 20, 2025 to submit its Financial Statements for Fiscal Year 2024.

On August 14, 2025, NFE POWER filed a document titled *Motion in Compliance with Resolution and Order* ("August 14 Motion") reporting that the entities contracted are three contractors for different types of services but that they don't substitute NFE POWER as operator of the system. NFE POWER submitted the following information and credentials, as applicable for each contractor:

1. Information and Credentials

- a. Brief summary of the contractor.
- b. List of names of supporting staff.
- c. Puerto Rico Department of State Certificate of Existence.
- d. Puerto Rico Department of State Certificate of Good Standing.
- e. Evidence of recent employee training.
- f. Puerto Rico College of Engineers and Surveyors License.
- 2. Description of the services that they provide to the equipment and systems of NFE Power.

Furthermore, NFE POWER reported the following:

NFE POWER hereby clarifies that it is the primary party' responsible for overseeing the operation of the system. The companies, persons and entities mentioned in the operational report are contractors that provide services in their specific areas of business and expertise, but they are not the "operators" of the system for regulatory and legal purposes. They are reported under Section 2.2 A.(1)(d) of the Operational Report for transparency purposes, but they do not substitute NFE POWER as the operator of the system and do not provide direct services to, nor invoice services to, Boehringer Ingelheim Animal Health, who is NFE POWER's sole customer in connection with the system.

Upon reviewing the August 1 Motion filed by NFE POWER, the Energy Bureau **TAKES NOTICE** of the information presented. The Energy Bureau **GRANTS** NFE POWER until October 20, 2025, to submit its financial statements for FY2024.

Upon reviewing the August 14 Motion filed by NFE POWER, the Energy Bureau **TAKES NOTICE** of the information presented. The Energy Bureau **DETERMINES** NFE POWER **COMPLIED** with the July 30 Resolution submitting the information and credentials of the

entities contracted as reported in its 2025 *Operational Report for Electric Service Companies* (Form NEPR-B03).

The Energy Bureau **WARNS** NFE POWER that failure to comply with this Resolution and Order will result in the imposition of fines, in accordance with Section 6.36 of Act 57-2014. ¹
