**MOTION IN COMPLIANCE WITH RESOLUTION AND ORDER  
DATED FEBRUARY 11, 2025**

**TO THE HONORABLE ENERGY BUREAU,**

**COMES NOW** the Puerto Rico Electric Power Authority ("PREPA") through its undersigned legal representation and, very respectfully, informs and requests as follows:

1. On January 4, 2025, PREPA filed a "Motion to Submit an Amendment for the Review and Approval of YFN Yabucoa Solar, LLC's PPOA" ("January 4 Motion") before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau"), submitting for evaluation and approval the Proposed Amended PPOA with YFN Yabucoa Solar, LLC ("YFN").

2. On February 11, 2025, the Energy Bureau issued a Resolution and Order ("Resolution") approving the Proposed Amended PPOA, subject to the modifications set forth in the Resolution.

3. In Part V, Section iii of the Resolution, the Energy Bureau ordered PREPA to file, within ten (10) business days following execution, a copy of the

executed Amended PPOA together with evidence of its filing with the Office of the Comptroller of Puerto Rico

4. In compliance with the Energy Bureau's Resolution and Order, PREPA hereby informs the Energy Bureau that the Amended PPOA with YFN Yabucoa Solar, LLC was executed on August 18, 2025. On the same date, PREPA filed the executed Amended PPOA with the Office of the Comptroller of Puerto Rico.

5. PREPA attaches hereto, as Exhibit A, a copy of the executed Amended PPOA, and as Exhibit B, the evidence of its filing with the Office of the Comptroller.

**WHEREFORE**, PREPA respectfully requests that the Energy Bureau: (1) take NOTICE of the present Motion; and (2) deem PREPA in compliance with the Resolution and Order dated February 11, 2025.
