**AMENDED MOTION REQUESTING AN ADDITIONAL EXTENSION OF TIME TO SUBMIT  
THE AUGUST 2025 B2A REPORT**

**TO THE HONORABLE PUERTO RICO ENERGY BUREAU:**

**COMES NOW** the Puerto Rico Electric Power Authority ("PREPA") through its undersigned legal representation and respectfully informs and requests as follows:

1. On June 25, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("June 25 Order") modifying the proposed budget and approving the Consolidated Annual Budgets for Fiscal Year 2024 ("FY24 Approved Budget").

2. The June 25 Order established several financial reporting requirements for PREPA, including the submission of a monthly Budget to Actual ("B2A Report") for HydroCo and HoldCo, based on a template provided by the Financial Oversight and Management Board ("FOMB"). This report must include:

- a. Explanation of material variances (greater than 10% and \$30 million),
- b. Income statement within the reporting package, and
- c. Monthly budget reporting.

3. On June 26, 2024, the Energy Bureau issued another Resolution and Order ("June 26 Order") regarding the review of the FY 2025 Budget. In that order, the Energy Bureau determined that the modified FY 2025 Budgets complied with Act

57-2014 and the 2017 Rate Order. The Energy Bureau also confirmed that all existing reporting requirements remain in full force and effect.

4. On August 15, 2025, PREPA filed a *Motion requesting extension of time to submit the August 2025 B2A Report* before this Energy Bureau, requesting an extension of ten (10) days to file the report, which expires today, August 25, 2025.

5. Today, August 25, 2025, PREPA filed a *Motion requesting additional time to submit its August 2025 B2A Report*, requesting a 30-day extension. Nonetheless, upon further consideration, PREPA respectfully submits this amended motion to clarify the circumstances that make an extension unavoidable. PREPA's consultants, Ankura Consulting Group, LLC, who provide the specialized expertise required for the preparation of the B2A Report, are currently negotiating their contractual agreement with PREPA. Until such agreement is finalized and executed, PREPA does not have the benefit of their technical assistance, which is indispensable to ensure that the B2A Report is accurate, comprehensive, and fully compliant with the Energy Bureau's requirements.

6. Considering these circumstances, PREPA respectfully requests additional time so that it may present the Energy Bureau with a complete and reliable filing that will meaningfully assist in the resolution of this proceeding. Therefore, PREPA understands that an extension until **September 8, 2025**, will suffice.

7. Moreover, this request is made in the utmost good faith and solely to ensure that the Energy Bureau receives a complete, accurate, and reliable August B2A Report. Granting this extension will not prejudice the orderly evaluation of the

proceeding; rather, it will facilitate the Energy Bureau's review by ensuring the submission of PREPA's August 2025 B2A Report is both comprehensive and precise, thereby avoiding inefficiencies and potential delays.

**WHEREFORE**, PREPA respectfully requests that: (a) the Energy Bureau take **NOTICE** of the information provided, and (b) **GRANT** the extension requested until September 8, 2025.
