RESOLUTION AND ORDER

On August 8, 2025, the Puerto Rico Electric Power Authority ("PREPA") filed a document titled *Informative Motion to Submit the Consolidated Project Plan* ("August 8 Motion") in the above-captioned case.

Upon review of the August 8 Motion, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") **DETERMINES** that said filing pertains to the submission of the Consolidated FEMA Accelerated Award Strategy ("FAAST") Project List and is not related to the matters addressed in this docket, which deals with the implementation of the Puerto Rico Electric Power Authority Integrated Resource Plan and Modified Action Plan.



Consequently, the Energy Bureau **ORDERS** its Clerk to:



The Energy Bureau is currently reviewing the August 8 Motion and will issue its determination in a separate resolution under Case No.: NEPR-MI-2021-0002.




