Hearing Examiner's Order Scheduling Conference; Granting Motion to Intervene of Solar United Neighbors

Conference to address questions on LUMA's full revenue requirement

On August 28, 2025, LUMA filed a Motion Submitting Revised Revenue Requirement. To address any questions about this submission, we will have a conference on **Thursday, September 4, 2025, at 1.30pm Atlantic**. To make that conference efficient, parties should email me their questions (informational, not argumentative) by **5.00pm Tuesday**. Put the questions in the email message, without numbering or bullets. This requirement does not preclude parties from raising additional questions at the conference. I will organize and issue the submitted questions by **1.30pm Wednesday**.

At this conference, I will also discuss with counsel, informally, ideas on at least the following subjects: procedural schedule, organization of the evidentiary hearing, and possible supplemental testimony on certain topics.

Motion to Intervene of Solar United Neighbors

On August 21, 2025, Solar United Neighbors (SUN) submitted a motion to intervene. SUN describes itself as "a national 501(c)3 non-profit organization dedicated to creating a clean, equitable, resilient energy system that benefits everyone." In Puerto Rico, SUN says, it "helps communities go solar by organizing bulk purchases or 'co-ops' of individually owned solar systems"; "helps individual homeowners in their journey of going solar by reviewing solar proposals, offering free educational presentations and information on solar, and providing ongoing support for solar owners"; and "invests in the development of Resilience Hubs in vulnerable communities." SUN says that it "was selected as lead grantee in the Department of Energy's ('DOE') Puerto Rico Resiliency Fund ERF Topic 2 grant for the creation of low-cost rooftop solar in Salinas for 150 single-family homes in vulnerable communities."

I grant SUN's motion to intervene for all the reasons I granted the Motion to Intervene of Solar and Energy Storage Association of Puerto Rico (SESA), in my Order dated July 7, 2025. I grant SUN's motion subject to these conditions: SUN must coordinate with SESA to avoid duplication, and SUN must accept this proceeding's scope, which is to set rates.
