ORDER TO SHOW CAUSE


On July 15, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("July 15 Resolution") ordering HORIZON ENERGY, LLC. ("Horizon") to, within fifteen (15) days, submit the credentials and information of the entity contracted to operate its system, as required under Section 2.02 (A)(1)(d) of Regulation 8701.<sup>1</sup>

The deadline granted by the Energy Bureau expired on July 30, 2025. To date, Horizon has not yet submitted the requested information.

As such, the Energy Bureau **GRANTS** Horizon **ten (10) additional days from the notification of this Order** to comply with the July 15 Resolution and **ORDERS** Horizon to **SHOW CAUSE**, within the same timeframe, as to why a fine of **ten thousand dollars (\$10,000)** shall not be imposed for non-compliance with the July 15 Resolution, in accordance with Section 6.36 of Act 57-2014.<sup>2</sup>

The Energy Bureau further **WARNS** Horizon that failure to comply with this Order will result in the imposition of fines under the referenced Section.


