RESOLUTION

On August 14, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("August 14 Resolution") through which, among others matters, granted Punta Lima Wind Farm, LLC ("Punta Lima") five (5) days to file evidence of payment of the filing fee for *Operational Report for Electric Service Companies* (Form NEPR-B03) and informing that the Operational Report, filed on March 31 with the *Motion to Request Confidential Treatment of 2025 Operational Report*, will not be deemed filed until evidence of payment of the applicable fee is submitted.


On August 19, 2025, Punta Lima filed a document titled *Confidential Motion in Compliance with August 14 Resolution and Order* ("August 19 Motion") presenting evidence of the filing fee for the *Operational Report for Electric Service Companies* (Form NEPR-B03) and requesting confidential designation and treatment to the Motion and attached documents.

Upon reviewing the documents filed by Punta Lima in the August 19 Motion, the Energy Bureau **DETERMINES** that Punta Lima **COMPLIED** with the August 14 Resolution requesting evidence of payment for the filing fee of Form NEPR-B03.

The Energy Bureau **TAKES NOTICE** of the *Operational Report for Electric Service Companies* (Form NEPR-B03) submitted with the March 31 Motion and **DETERMINES** Punta Lima **COMPLIED** with Section 2.02(A)(1) of Regulation 8701.

Upon examination of the arguments brought forth by Punta Lima, the Energy Bureau **GRANTS** confidential designation and treatment to the August 19 Motion and the attached documents.
