RESOLUTION AND ORDER

On July 24, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("July 24 Resolution") that granted Jireh Solar LLC ("Jireh") thirty (30) days to: (i) submit the necessary information and documentation¹ required to demonstrate compliance with the applicable provisions, in order to facilitate the proper evaluation of its Request of Certification, in compliance with all requirements of Sections 3.03 and 3.07 of Regulation 8701², and (ii) clarify whether it intends to request certification as a microgrid, either at this time or at a later date, pursuant to Regulation No. 9028³.


The deadline granted by the Energy Bureau expired on August 25, 2025. To date, Jireh has not submitted the requested information.

The Energy Bureau **GRANTS** Jireh an additional **thirty (30) days** to review the Regulation and submit the remaining requirements set forth in the July 24 Resolution.


The Energy Bureau **WARNS** Jireh that shall it wish to proceed and/or if it intends to operate or offer electric services in Puerto Rico, it must submit all the information required in Regulation 8701 and comply with the applicable criteria.


Failure to provide the requested information will result in deeming the request for certification as not filed, in accordance with the referenced regulation.


