## **RESOLUTION AND ORDER**

On June 18, 2025, Global Power Solutions (PR) LLC ("Global") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a Request for Certification as an Electric Power Service Company ("Application") as well as a series of supporting documents.

On July 16, 2025, the Energy Bureau issued a Resolution and Order ("July 16 Resolution") in which the Energy Bureau determined that Global's Application was incomplete and granted it thirty (30) days to submit all necessary supporting documentation to meet the requirements in Regulation 8701.

On August 15, 2025, Global filed a motion titled *Request for Extension* ("August 15 Motion"), requesting the Energy Bureau a fifteen (15) day extension to submit the required documentation.

The Energy Bureau **GRANTS** Global **fifteen (15) additional days**, from the notification of this Resolution and Order, to submit all necessary supporting documentation to meet the requirements set forth in Regulation 8701.<sup>1</sup>
