**SUBJECT:** Resolution and Order addressing the Motion for Extension of Time to File Memorandum of Law in Support of Confidential Treatment of Exhibits 1 and 2 Submitted on February 28, 2025, filed by LUMA, March 10, 2025.

**RESOLUTION AND ORDER**

On January 7, 2025, this Puerto Rico Energy Bureau of the Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("January 7 Order") whereby it initiated the captioned proceeding pursuant to Act 57-2014<sup>1</sup>, to investigate the causes of, and the investigative or corrective actions taken by LUMA<sup>2</sup>, regarding an outage event affecting the Puerto Rico electric system which occurred on December 31, 2024 (the "Incident") and causing certain generation units to go out of operation, including some operated by the Puerto Rico Electric Power Authority and others privately operated. The Energy Bureau ordered LUMA to submit, on or before 12:00 pm of January 15, 2025, a response to a Request for Information set forth in the January 7 Order.

On February 28, 2025, LUMA filed a document titled *Motion Submitting Final Report of the Investigation and Request for Confidential Treatment* ("February 28 Motion"), through which LUMA submitted, as Exhibit 1, the Final Report of the incident object of investigation ("Final Report") and, as Exhibit 2, a ShareFile folder with the documents and information referenced in the Final Report. On February 28 Motion, LUMA also requested that both Exhibit 1 and Exhibit 2 be held confidential during and after the conclusion of such investigation because it contains confidential information that should be protected as Critical Energy Infrastructure Information. LUMA also informed the Energy Bureau that, pursuant to the Policy on Confidential Information, it would be submitting within ten (10) days a Memorandum of Law in support of the request for confidential treatment of Exhibits 1 and 2.

Exhibit *Motion for Extension of Time to File Memorandum of Law in Support of Confidential Treatment of Exhibit 1 and 2 Submitted on February 28, 2025* ("March 10 Request"), through which LUMA informs that, given the extensive number of documents comprising Exhibit 2, they request an additional extension of ten (10) days to complete the Memorandum of Law in support of the mentioned Exhibit 1 and 2.


