## MOTION IN COMPLIANCE WITH RESOLUTION AND ORDER DATED AUGUST 14, 2025 TO THE PUERTO RICO ENERGY BUREAU:

**COMES NOW** the Puerto Rico Electric Power Authority ("PREPA"), through its counsel of record, and respectfully submits and prays as follows:

- 1. On August 14, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("August 14 Resolution") requiring PREPA, LUMA Energy, LLC ("LUMA"), and Genera PR, LLC ("Genera") to submit detailed information related to their use of funds under the Energy Grid Rehabilitation and Reconstruction Cost Share Program ("ER1 Program"), which is administered by the Puerto Rico Department of Housing ("PRDOH") and funded through CDBG-DR grants.
- 2. Pursuant to its statutory oversight powers under Act 57-2014 and Act 17-2019, the Energy Bureau directed PREPA, LUMA, and Genera to submit, within fifteen (15) days of the August 14 Resolution, a detailed report using the template identified as Attachment B to the Resolution.
  - 3. In compliance with the August 14 Resolution, PREPA hereby submits as

Exhibit A, the template provided by the Energy Bureau, and as Exhibit B – PREPA

Project Submittal Consolidated Timeline- ER1 Program.

WHEREFORE, for the reasons stated above, PREPA respectfully requests that

the Energy Bureau take notice of the present Motion and deem PREPA in

compliance with the August 14 Resolution.
