MOTION FOR ADDITIONAL EXTENSION OF TIME TO SUBMIT RESPONSE TO REQUEST FOR CERTIFICATION

TO THE HONORABLE ENERGY BUREAU:

COMES NOW, AES Ilumina, LLC ("AES Ilumina" or the "Company"), represented by the undersigned attorneys, and very respectfully states and prays as follows:

- 1. On August 22, 2025, AES Ilumina requested a ten-day extension of time to comply with the Puerto Rico Energy Bureau's Resolution and Order, entered on August 7, 2025, requiring the Company to submit the credentials and other information of the entity contracted to serve as its system operator (the "Request"). The Energy Bureau granted this extension by Resolution and Order issued on August 29, 2025, and awarded AES Ilumina until Friday, September 5, 2025, to submit the credentials.
- AES Ilumina has been working diligently gathering the documents and information necessary to prepare a comprehensive response. However, due to the Request's broad scope, the Company is still in the process of gathering, identifying, and analyzing the necessary information to ensure its response is both accurate and complete.
- 3. In particular, the Request requires AES Ilumina to provide detailed technical information regarding the operational qualifications of the contracted system operator, along with a description of the services, equipment, and systems to be managed by the entity. Compiling this information requires contacting various stakeholders and reviewing multiple sources and dates back in many years. Therefore, despite its best efforts, the Company has not yet been able to finalize gathering all documents and information for its response.
- 4. AES Ilumina is committed to complying with the Energy Bureau's directives and providing a complete, thorough, and responsible response to the Request. However, given the scope of the Request, the Company requires additional time to ensure the information provided in its response is accurate and complete.
 - 5. Based on the above, AES Ilumina respectfully requests an additional extension of

twenty (20) days, until September 25, 2025, to submit its response.
