**SUBJECT:** Deficient Filing; Closure of Case.

**RESOLUTION AND ORDER**

On April 23, 2025, YFN Yabucoa Solar, LLC ("YFN") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") the following documents ("April 23 Submission"):

- Personal Information Form (NEPR-B01)
- Continuation Sheet for Affiliate or Subsidiary (NEPR-B02)
- Copy of the Good Standing Certificate issued by the Puerto Rico State Department

The April 23 Submission consists solely of the information and includes no evidence addressing the regulatory criteria established in Regulation 8701.<sup>1</sup>

On July 21, 2025, the Energy Bureau determined the April 23 Submission was deficient for certification evaluation and granted YFN thirty (30) days to review the Regulation and submit the remaining requirements ("July 21 Resolution"). The Energy Bureau further warned YFN that shall it wish to proceed and/or if it intends to operate or offer electric services in Puerto Rico, it must submit all the information required in Regulation 8701 and comply with the applicable criteria.

The deadline to comply with the July 21 Resolution was **August 20, 2025**. YFN has shown no interest in continuing with the certification process, as it failed to appear before the Energy Bureau in response to the July 21 Resolution.


As stated in Art 3.03(G) of Regulation 8701, Requests for Certification shall be deemed submitted if the appropriate fee has been paid, they contain all the information, data, and documents required by Regulation 8701, and once the Energy Bureau has confirmed and given written notice that the Request in question is complete. **Any Requests that do not comply with every applicable provision of Regulation 8701 shall be deemed to have never been submitted and shall no legal effect whatsoever.**


The Energy Bureau **DEEMS** the April 23 Submission as **not filed** and **ORDERS** its Clerk to close and archive this case, for administrative purposes.
