On September 8, 2025, the Institute of Competitiveness and Economic Sustainability ("ICSE" as its Spanish acronym) filed its Motion Submitting Expert Witness Report. At page 3 of the Motion, ICSE stated that "it intends to further reply to Dr. Susan Tierney's testimony given the mischaracterizations of ICSE previous filings and to answer its substance."

My prior orders, including the revised procedural schedule issued on September 9, 2025, make clear that there is no scheduled slot for responsive intervenor prefiled testimony. The time for intervenors to contest each other's positions is at the evidentiary hearing, either through cross-examination by counsel or through witness-to-witness questions during a panel.

As to ICSE's concerns about Dr. Tierney's prefiled testimony—specifically, I assume, about her characterization of dialogue occurring before the Title III Court: What matters to the Energy Bureau is what is presented to the Energy Bureau. At present, I'm not seeing the value to our evidentiary record of a debate about what was said in some other forum's evidentiary record. Nor was I clear about how any proposition that the Energy Bureau might state in its final rate order would receive support from anything in Dr. Tierney's prefiled testimony on the subject of practicability. Please prepare for our evidentiary hearing accordingly, so that we use everyone's time cost-effectively.
