Hearing Examiner's Interim Protective Order on Inadvertent Disclosure

I understand from Genera that on August 27, 2025, it uploaded a supplemental response to ROI #NonPhysOps-35. The supplemental response included an attachment answering part b of the ROI: PC-of-GENERA-NONPHYS_OPS-35 – INSURANCE (B). The attachment contained a table with unredacted confidential information about the cost of Genera's insurance. Genera now asks to remove the attachment and replace it. The attachment was accessible to all parties until September 23, 2025, when the Accion Platform administrator removed it immediately after learning of the problem.

Pending a ruling on confidentiality, all shall follow these instructions:

Platform Administrator: Within 48 hours, the Accion Platform administrator must provide me a sworn certification confirming the document's deletion and a log of all users who accessed it, including timestamps.

Genera: Genera shall file its Memorandum of Law on its confidentiality claims, and upload to the platform the redacted and confidential versions of the attachment.

All Parties: All parties and their representatives must (a) immediately cease reviewing the attachment uploaded on August 27, 2025; and (b) within 48 hours, sequester and destroy all copies of the attachment.

Only individuals who have signed an NDA will have access to and may use, the corrected confidential document. Individuals who have signed an NDA and PREB Consultants must ensure any derived work product from the confidential information is clearly marked confidential. All other individuals shall use the corrected redacted document and destroy any work product derived from the confidential information.
