SUBJECT: Resolution regarding Luma's September 26, 2025, Informative Motion.

## RESOLUTION AND ORDER

On September 26, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("September 26 Resolution") determining stay sine die all actions.

On September 26, 2025, LUMA filed a document titled Informative Motion and Request for Modification of Resolution and Order of September 26, 2025 ("September 26 Motion"), in which it requested the Energy Bureau to modify the September 26 Resolution to allow to continue with the SO1 Agreements. Exhibit 1 of the September 26 Motion specifies two projects which are part of the SO1 Agreements, already approved by the Energy Bureau, alleging they are ready to be signed in the next five (5) days. LUMA requested that Exhibit 1 of the September 26 Motion be treated as confidential information based that the information reflects internal strategies and ongoing negotiating terms.

With the most recent filings of Puerto Rico Electric Power Authority ("PREPA") and the proponents of the SO1 Agreements in this procedure the Energy Bureau determined that the execution of the ASAP Agreements was futile. The September 26 Motion alleges that is not the case for two specific projects which are ready for execution.

Based on these allegations made by LUMA and in the best interest of the ratepayers in terms of price and timely execution of the BESS projects greatly needed in the Electric Power System, the Energy Bureau MODIFIES the September 26 Resolution and allows PREPA to proceed with the execution of the two projects described in Exhibit 1 of the September 26 Motion. The Energy Bureau ORDERS PREPA to within five (5) days of receiving all the required documentation from these two projects and approval from the Financial Oversight and Management Board ("FOMB") to file the executed contracts with the Energy Bureau. The proponents of the two projects have five (5) days from the issuance of this Resolution and Order to file with PREPA all the required documentation to execute the agreements.

The Energy Bureau **GRANTS** confidential treatment to Exhibit 1 of the September 26 Motion since it has information ongoing negotiating terms that if made public at this stage may harm such negotiations with PREPA.

The September 26 Resolution remains unaltered except for the modification stated herein.
