SUBJECT: Eligibility Criteria and Project Evaluation Procedure to Be Followed by the Puerto Rico Electric Power Authority in the Procurement of Renewable Energy, with or without Storage Capacity, Qualifying for ITCs, Pursuant to the Governor's Executive Order OE-2025-047 and the Deadlines Established by the "One Big Beautiful Bill Act".

RESOLUTION AND ORDER

On September 26, 2025, the Energy Bureau issued a Resolution and Order ("September 26 Resolution") in the captioned case, through which it provided the Puerto Rico Electric Power Authority ("PREPA") with guidelines for the implementation of the accelerated acquisition of renewable resources under Executive Order OE-2025-047. The following documents were included as part of the guidance: (i) Request for Proposals; (ii) Energy Storage Service Agreement Interconnecting at Existing POI; (iii) Energy Storage Service Agreement Interconnecting with New Sectionalizer; (iv) Power Purchase and Operating Agreement Interconnecting at Existing POI; (v) and Power Purchase and Operating Agreement Interconnecting with New Sectionalizer (collectively, the guidance Documents). The Energy Bureau has reassessed its position regarding the Proposal Security recommended as part of the Guidance Documents in its September 26 Resolution. Although the Guidance Documents recommend the use of a Proposal Security, including a determinable amount, the Energy Bureau, upon further consideration, defers to PREPA the determination of whether to require a Proposal Security as part of the acquisition process, recognizing that such requirement is intended to protect PREPA's interests. The intention is not to impose overly burdensome requirements on proponents; however, it is reiterated this is ultimately a matter for PREPA to decide, including whether to retain, eliminate, or modify the requirement in the Guidance Documents.

The Energy Bureau WARNS PREPA that failure to comply with this Resolution and Order will result in the imposition of fines under Section 6.36 of Act 57-2014.
