RESOLUTION

On August 27, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("August 27 Resolution") through which it denied Genera PR, LLC ("Genera's") request for consolidation of cases NEPR-AP-2024-0001; NEPR-MI-2020-0001; and NEPR-IN-2025-0004.


On September 16, 2025, Genera filed a document titled *Motion for Reconsideration of Order Denying Consolidation of Cases NEPR-AP-2024-0001 and NEPR-IN-2025-0004* ("September 16 Motion"). In its September 16 Motion, Genera requested reconsideration of the August 27 Resolution and the consolidation of the instant docket and Case No.: NEPR-IN-2025-0004.


Upon review of the September 16 Motion, the Energy Bureau **REAFFIRMS** its August 27 Resolution and **DENIES** Genera's request for reconsideration and consolidation of cases number NEPR-AP-2024-0001 and NEPR-IN-2025-0004.


