**RESOLUTION AND ORDER**

On September 10, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("September 10 Resolution") granting AES Ilumina, LLC ("AES Ilumina") until September 25, 2025, to comply with the August 7 Resolution and Order ("August 7 Resolution") requesting to: (i) submit the credentials of the entity contracted to operate its system as required under Section 2.02 (A)(1)(d) of Regulation 8701<sup>1</sup> and (ii) describe what services, equipment, and systems it will operate.


On September 25, 2025, AES Ilumina filed a document titled *Motion Submitting Responses to the Order of August 7<sup>th</sup>* ("August 25 Motion") submitting redacted and unredacted versions of information and documents to comply with the August 7 Resolution and requesting confidential treatment. In the September 25 Motion, AES Ilumina requested ten (10) days to submit the corresponding memorandum of law in support of the confidential treatment.

Upon reviewing the September 25 Motion, the Energy Bureau **DETERMINES** AES Ilumina complied with the August 7 Resolution.


The Energy Bureau further **GRANTS** AES Ilumina **ten (10) days** to submit the memorandum of law, as requested.

The Energy Bureau **WARNS** AES Ilumina that failure to comply with this Resolution and Order will result in the imposition of fines in accordance with Section 6.36 of Act 57-2014.<sup>2</sup>
