Hearing Examiner's Order Scheduling Conference for October 16, 2025

This Order schedules a conference on **October 16, 2025, from 11.30am to 1.30pm Atlantic**. I expect to discuss with counsel at least the following topics:

- Substantive panels
- Treatment of exhibits
- Treatment of confidential materials during the hearing
- Expectations for cross-examination
- Hearing schedule (no hearing Nov. 19—government holiday)
- Hearing room logistics
- Organization of the Energy Bureau's final order in this proceeding
- Post-hearing briefs
- Interpretation of the last sentence from Act 57, section 6.25(c)¹

Concerning section 6.25(c), my question is what detail must appear in the Day 240 Order to satisfy the statute. Here are two options:

- The Order specifies all the permanent rates.
- The Order establishes all the cost inclusions and exclusions necessary to establish the revenue requirement, all the methodologies necessary to establish rate design, and all guidance necessary to reconcile the permanent rates with the provisional rates. Then the actual permanent rates finally appear in a compliance filing submitted to and then approved by the Energy Bureau after Day 240.

¹ The sentence reads:

The review and the order issuance processes shall not exceed one hundred eighty (180) days from the Energy Bureau's determination by resolution that the rate review request is complete; provided, however, that the Energy Bureau may extend the review process for an additional term that shall not exceed sixty (60) days.
