RESOLUTION AND ORDER

On September 25, 2025, AES Ilumina, LLC ("AES Ilumina") filed a document before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") titled *Motion Submitting Responses to the Order of August 7th* ("September 25 Motion") submitting redacted and unredacted versions of information and documents to comply with the August 7, 2025, Resolution and requesting confidential treatment. In the September 25 Motion, AES Ilumina requested ten (10) days to submit the corresponding memorandum of law in support of the confidential treatment.


On October 2, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("October 2 Resolution") granting AES Ilumina ten (10) days to submit the memorandum of law as requested in its September 25 Motion.


On October 6, 2025, AES Ilumina filed a document titled *Memorandum of Law in Support of Request for Confidential Treatment of Certain AES Ilumina LLC's Responses to the August 7th Order* ("October 6 Motion"). AES Ilumina requested confidential designation and treatment of the specified portions of Exhibit 1 to the September 25 Motion.

The Energy Bureau **GRANTS** confidential designation and treatment to Exhibit 1 to the September 25 Motion and **TAKES NOTICE** AES Ilumina filed a public redacted version of the referenced document in accordance with Section 6.15 of Act 57-2014¹; Section 1.15 of Regulation 8701²; and *In Re: Policy on Management of Confidential Information in Procedures before the Commission*, Case No.: CEPR-MI-2016-0009, Resolution and Order issued on August 31, 2016 ("Confidential Treatment Resolution").
