**SUBJECT:** Approval of Model Customer Bill and Certification as Demand Response Aggregator.

## **RESOLUTION AND ORDER**

#### I. **Background**

On June 3, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") certified EnFin Energy Corp. ("EnFin") as an Electric Service Company.

August 7, 2025, the Energy Bureau issued a Resolution and Order ("August 7 Resolution"), through which it ordered EnFin to address certain deficiencies in the model customer bill submitted, under the applicable provisions of Regulation 8863.1

On September 9, 2025, EnFin filed a document titled Request for Certification as Demand Response Aggregator ("September 9 Motion"). In addition to meeting the requirements of Regulation 8701, EnFin described the type of demand response resources sought to be developed and aggregated by EnFin. Specifically, batteries installed in the end-users that are also used to provide electric service to EnFin's residential customers under power purchase agreements. EnFin intends to utilize the CBES program provided by LUMA Energy, LLC and LUMA Energy ServCo, LLC (referred to jointly as "LUMA"). EnFin also provided the privacy and security policy required by Section 6.01 of Regulation 9246.<sup>2</sup> Additionally under Section 2.03, Enfin submitted the terms and conditions of the customers participating in its Demand Response Program. EnFin requested confidential treatment to both attachments submitted with the September 9 Motion, arguing the information therein qualifies as a trade secret.

On September 10, 2025, EnFin filed a document titled Motion in Compliance Submitting Corrected Model Bill ("September 10 Motion"). EnFin provided updated and corrected versions of its Model Bill in Spanish and English.

#### II. **Conclusion**

Upon review of the September 9 Motion, the Energy Bureau **CERTIFIES** EnFin as a Demand Response Aggregator under the special circumstances of the Transition Period Plan ("TPP") and LUMA's Emergency Demand Response Program.

Certification Expiration Date: <u>June 30, 2028</u>.<sup>3</sup>

Certification can be renewed upon EnFin's request. Renewal requests shall be filed at least thirty (30) days before the Expiration Date (June 30, 2028).

The Energy Bureau **ORDERS** the Clerk's Office to include EnFin in the List of Certified Demand Response Aggregators at the Energy Bureau's website, including EnFin's contact information, as required by Section 2.02(C) of Regulation 9246.

The Energy Bureau **GRANTS** confidential designation and treatment to Attachments 1 and 2 to the September 9 Motion.

Upon review of the September 10 Motion, the Energy Bureau **APPROVES** EnFin's Model Bill and **DETERMINES** that both versions of the bill comply with Regulation 8863 and the August 7 Resolution.

The Energy Bureau **WARNS** EnFin that failure to comply with this Resolution and Order will result in the imposition of fines under Section 6.36 of Act 57-2014.<sup>4</sup>
