## Hearing Examiner's Order Extending Deadline to Upload Documents Marked for Identification

Appendix A of my October 16, 2025, order required parties to upload materials submitted through October 10 on the Accion platform in the Marked for Identification folder, by October 22, 2025.

Accion is updating the Exhibits application on the platform to accept materials with attachments in two different formats, as one document marked for identification. For example, an ROI response in pdf and an attached spreadsheet in Excel will be marked for identification as one exhibit numbered Party Ex. 100 and Party Ex 100.1. Accion expects to add this feature by the end of day October 23.

I am extending the deadline for Parties to upload materials to be marked for identification until 5 pm, Monday October 27. Materials with multiple documents in the same format (e.g., 3 pdf documents associated with one ROI) should be combined and uploaded as one document. Parties must file **Objections** to any material marked for identification no later than the **new deadline of October 31**. Responses are due three days later.
