**NOTICE OF APPEARANCE, REQUEST FOR NOTICE AND
WITHDRAWAL AS ATTORNEY OF RECORD**

TO THE HONORABLE ENERGY BUREAU,

COMES NOW the Puerto Rico Electric Power Authority ("PREPA") through its undersigned counsel and respectfully informs and requests as follows:

1. The undersigned counsel, Alexis G. Rivera Medina, from the law firm González & Martínez Law Offices, P.S.C. ("G&M"), hereby informs that it is withdrawing as counsel of record in the above-captioned case as it has ceased its employment relationship with G&M.

2. Mr. Rivera now serves as the Director of PREPA's Legal Affairs Department.
