MOTION TO SUBMIT PREPA'S REBUTTAL TESTIMONY TO THE PUERTO RICO ENERGY BUREAU'S CONSULTANT ENG. JUSTO GONZÁLEZ ON THE MATTER OF GENERATION

TO THE ENERGY BUREAU,

COMES NOW, the Puerto Rico Electric Power Authority ("PREPA"), through its undersigned legal counsel and, very respectfully, states and prays as follows:

- 1. On November 10, 2025, PREPA filed a Motion for Extension of Time to File Surrebuttal on Generation Expert Report, which was approved on November 11th.
- 2. In compliance with said order, PREPA submits its Surrebuttal Written Testimony by Eng. Fernando Osorio-Cano, PREPA's Director of Operations, and Eng. William Sullivan, Project Manager from Witt O'Brien's PR, LLC, as Exhibit A, including its Exhibits 1 and 2.
- 3. At the time of this filing, PREPA respectfully informs the Energy Bureau that it is finalizing the execution of Mr. Sullivan's attestation, since he currently resides in the state of Pennsylvania. soon as it becomes available. PREPA submits that accepting the testimony now

will avoid unnecessary disruption to the scheduling of this proceeding and will

ensure that the evidentiary record continues to develop in an orderly and

efficient manner.
