**MOTION TO INFORM COMPLETION OF VEGA BAJA DECOMMISSIONING PLAN
AND TO REQUEST RELIEF FROM QUARTERLY REPORTING REQUIREMENT**

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW GENERA PR LLC (“Genera”), as agent of the Puerto Rico Electric Power Authority (“PREPA”),¹ through its counsels of record, and respectfully submits and prays as follows:

1. On October 31, 2024, the Energy Bureau issued a Resolution and Order titled *Approval of the Vega Baja Decommissioning Plan* ("October 31st Resolution"). In the October 31st Resolution, the Energy Bureau determined that the decommissioning of the Vega Baja Power Station submitted by Genera aligns with the Approved Integrated Resource Plan ("Approved IRP")² and the strategic initiatives for transitioning Puerto Rico's energy infrastructure towards renewable sources.

¹ Pursuant to the *Puerto Rico Thermal Generation Facilities Operation and Maintenance Agreement* (“LGA OMA”), dated January 24, 2023, executed by and among PREPA, the Puerto Rico Public-Private Partnerships Authority and Genera, Genera is the sole operator and administrator of the Legacy Generation Assets (as defined in the LGA OMA) the sole entity authorized to represent PREPA before the Energy Bureau with respect to any matter related to the performance of any of the O&M Services (as defined in the LGA OMA) provided by Genera under the LGA OMA.

2. On December 18, 2024, Genera filed a document titled *Motion to Submit the Revised Updated Decommissioning Plan* ("December 18th Motion"). Through the December 18th Motion, Genera submitted the fully revised Updated Decommissioning Plan incorporating all mandated changes set forth in the December 13, 2024, Resolution & Order. Genera submitted through the December 18th Motion the corresponding redlined version, reflecting the changes conducted by Genera's revision to the Updated Decommissioning Plan.

3. On December 19, 2024, the Energy Bureau issued a Resolution titled *Approval of the Vega Baja Decommissioning Plan* ("December 19th Resolution"). Through the December 19th Resolution, the Energy Bureau, after reviewing the submitted documents, determined that the Updated Decommissioning Plan dated December 16, 2024, complies with the requirements set forth by the Energy Bureau.

4. In compliance with Section 11.1 of the approved Vega Baja Decommissioning Plan, the October 31st Resolution and the December 19th Resolution, Genera has submitted quarterly progress reports to the Energy Bureau detailing milestones completed, up-to-date expenditures, description of work completed and regulatory compliance.

5. On July 29, 2025, Genera submitted a quarterly report whereby it informed the Energy Bureau of the completion of the Vega Baja Decommissioning Plan. Specifically, it informed demolition activities were completed on June 11, 2025, final restoration was completed on June 21, 2025, and subcontractors demobilized from the site on June 26, 2025.

6. Considering that the Vega Baja Decommissioning has been completed, Genera respectfully submits that it is no longer necessary to continue providing quarterly progress reports on the decommissioning project. Accordingly, Genera respectfully requests that the Energy Bureau grant relief from the quarterly reporting requirement set forth in Section 11.1 of the

Decommissioning Plan, as conditionally approved by October 31st Resolution and subsequently approved by the December 19th Resolution.

WHEREFORE, Genera respectfully requests that this Energy Bureau **take notice** of the above for all purposes; **grants** Genera's requests for relief from the quarterly reporting requirement set forth in Section 11.1 of the Decommissioning Plan, and **deem** Genera in compliance with the October 31st Resolution and the December 19th Resolution.
