**MOTION TO SUBMIT NOTARIZED SWORN STATEMENT OF WILLIAM SULLIVAN FROM THE  
STATE OF PENNSYLVANIA FOR PREPA'S WRITTEN REBUTTAL TESTIMONY SUBMITTED ON  
NOVEMBER 13, 2025**

**TO THE ENERGY BUREAU,**

**COMES NOW**, the Puerto Rico Electric Power Authority ("PREPA"), through its undersigned legal counsel and, very respectfully, states and prays as follows:

1. On November 13, 2025, PREPA filed a *Motion to Submit PREPA's Rebuttal Testimony to the Puerto Rico Energy Bureau's Consultant Eng. Justo González on the Matter of Generation* ("Rebuttal Testimony Motion"). In this motion, PREPA submitted the Rebuttal Written Testimony of Mr. Fernando Osorio and Mr. William Sullivan, as *Exhibit A*, together with *Exhibits 1 and 2* containing their respective resúms. Mr. Osorio's statement was duly sworn and notarized by Notary Public Fabiola María Rolsa Roldan, duly authorized in the Commonwealth of Puerto Rico.

2. In the Rebuttal Testimony Motion, PREPA also informed the Energy Bureau that it was in the process of securing notarization of Mr. Sullivan's sworn statement in the Commonwealth of Pennsylvania.

3. Accordingly, PREPA now submits, as *Exhibit 3*, Mr. Sullivan's duly notarized sworn statement, executed on November 14, 2025, in Philadelphia,

Pennsylvania. *Exhibit 3* reflects that Notary Mikhi Marie Wright is a duly commissioned Notary Public for the State of Pennsylvania, County of Philadelphia, with a commission expiring on March 18, 2029. On another note, PREPA confirms that no modifications were made to the Rebuttal Written Testimony of Mr. Osorio or Mr. Sullivan.

4. PREPA respectfully requests that the Energy Bureau substitute the previously submitted, non-notarized sworn statement for Mr. Sullivan with *Exhibit 3*, attached herein, as the notarized sworn statement for his testimony.

WHEREFORE, PREPA respectfully requests that the Energy Bureau: (i) **TAKE NOTICE** of the foregoing; (ii) **ACCEPT** *Exhibit 3* as Mr. Sullivan's validly sworn and notarized statements before Notary Public Mikhi Marie Wright in the State of Pennsylvania, County of Philadelphia; (iii) and **DEEM** PREPA's filing of the Rebuttal Written Testimony and all corresponding sworn statements complete and duly notarized.
