MOTION IN COMPLIANCE WITH THE RESOLUTION AND ORDER OF OCTOBER 21, 2025

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW Global Power Solutions (PR) LLC ("Global Power"), through the undersigned legal counsel and respectfully states and pray:

1. On September 15, 2025, Global Power submitted to the Puerto Rico Energy Bureau ("Energy Bureau") several documents and information as part of its Request for Certification as an Electric Service Company and as required by the Energy Bureau in its July 16, 2025 Resolution and Order ("July 16 Resolution"). In that same filing, Global Power also requested relief from certain outstanding requirements, including deferral of the *Request for Certification Electric Power Companies (Form NEPR-B04)* Filing Fee, exemption from filing *Gross Revenue and Financial Statements Electric Power Companies (Form NEPR-B05)* and an exemption from filing permits and certified financial statements.

2. On October 21, 2025, the Energy Bureau issued a Resolution and Order (the "October 21 Resolution"), in which it determined, among other things, that Global Power had partially complied with the July 16 Resolution. The Energy Bureau noted that certain documents remained pending

and that Global Power had submitted an incorrect fee for the Operational Report, as the applicable

fee for the type of electric service to be offered by Global Power is \$2,000, not the \$800 previously

paid. The Energy Bureau however granted a thirty (30)-day period, from the notification of the

October 21 Resolution (i.e., until November 20, 2025), for Global Power to provide an update on

the status of the Agreement (discussed below) and to submit other outstanding documentation.

3. Moreover, the October 21 Resolution explicitly deferred several requirements contingent

upon the formalization of the Agreement. Specifically, the Energy Bureau ordered that the

remaining balance of \$1,200 for the Operational Report fee be submitted once the Agreement is

formalized. Likewise, the Energy Bureau granted a deferral of the filing fee for the Request for

Certification until the execution of the Agreement and an exemption from the requirements to

submit Certified Financial Statements for Fiscal Year 2025 and the Gross Revenue and Financial

Statement Form (Form NEPR-B05) as well as exemption from the requirements to submit permits,

authorizations and endorsements until the execution of the Agreement.

4. The Agreement referenced in the October 21 Resolution relates to the emergency

temporary power generation procurement process initiated in March 2025, under which the Puerto

Rico Electric Power Authority ("PREPA"), through the Third-Party Procurement Office ("3PPO"),

issued RFP 3PPO-0314-20-TPG (the "RFP"), and subsequently reissued the RFP under RFP

3PPO-0314-20-TPG2 on July 15, 2025 in which 3PPO sought bids to deliver power generation

solutions to the requested sites and deliver power generation to the generation units. The

Agreement concerns the sale of electrical power to PREPA, which forms a critical component of

Global Power's anticipated operations as an Electric Service Company.

5. In compliance with the Energy Bureau's directive in the October 21 Resolution, Global

Power informs this Honorable Energy Bureau that, as of the date of this Motion, the Agreement

has not yet been executed. Despite Global Power's continued efforts, certain matters that need

to be addressed with the corresponding governmental entities remain pending and must be resolved in order to advance the Agreement.

- 6. Note that the Agreement must be approved by PREPA, the Energy Bureau, and the Fiscal Oversight and Management Board of Puerto Rico before its execution.
- 7. In light of the foregoing, Global Power respectfully requests an additional sixty (60)-day extension, counted from the current deadline of November 20, 2025, to provide a subsequent status update to the Energy Bureau. This time is necessary to address the complex technical, financial, and legal matters related to providing electric service in Puerto Rico, and to secure the final approvals and signatures from all parties involved in the transaction.

WHEREFORE, Global Power Solutions (PR) LLC respectfully requests this Honorable Energy Bureau to (1) TAKE NOTICE of the status report that the Agreement has not yet been executed; and (2) GRANT Global Power an additional extension for a sixty (60)-day period from the current deadline of 20 November 2025 to file the next status update on the execution of the Agreement and compliance with outstanding documentation.
