**SUBMISSION OF THE MONTHLY REPORT ON THE SYSTEM  
RELIABILITY METRICS FOR OCTOBER 2025**

**TO THE PUERTO RICO ENERGY BUREAU:**

**COMES NOW, LUMA ENERGY SERVCO, LLC** (“LUMA”), through the undersigned legal counsel and respectfully states and requests the following:

**I. Introduction**

LUMA respectfully submits this motion in compliance with the Puerto Rico Energy Bureau’s (“Energy Bureau”) directives regarding the reporting of system reliability metrics. This filing provides the required data for October 2025, pursuant to the Energy Bureau’s order entered on May 16, 2025, and in accordance with the applicable provisions of the *Puerto Rico Transmission and Distribution System Operation and Maintenance Agreement*<sup>1</sup> and prior orders in this proceeding.

**II. Relevant Procedural Background**

The requirement to submit quarterly reports on specified system data of the Puerto Rico Electric Power Authority (“PREPA”) arises under the *Resolution and Order* issued by the Energy

<sup>1</sup> The *Transmission and Distribution System Operation and Management Agreement* was executed by LUMA Energy, LLC, LUMA Energy ServCo, LLC, the Puerto Rico Electric Power Authority, and the Puerto Rico Public-Private Partnerships Authority on June 22, 2020. This agreement is supplemented and amended by the *Puerto Rico Transmission and Distribution System Operation and Maintenance Supplemental Terms Agreement*, which was also executed on the same day. This document is referred to as the “T&D OMA.”

Bureau on May 14, 2019, in this proceeding. Following the *Resolution and Order* issued on December 30, 2020, the quarterly system data is due on the 20<sup>th</sup> day of the month after each quarter closes.<sup>2</sup>

According to Section 5.6 of the T&D OMA, LUMA, as an agent of PREPA, submits systems data regarding the Transmission and Distribution System (“T&D System”).

On May 16, 2025, the Puerto Rico Energy Bureau issued a *Resolution and Order* with the subject *Response to LUMA's January 15 Motion, Response to Genera's February 3 and February 10 Motions, System Reliability Metric Reporting Frequency, and Additional System Reliability Metrics* (the “May 16 Order”). The Energy Bureau directed LUMA to begin reporting by the 20<sup>th</sup> day of the following month, *inter alia*, the reliability metrics outlined in Section C(a), to wit: System SAIDI (T&D FYTD), System Monthly SAIDI (T&D), System SAIFI (T&D FYTD) and System Monthly SAIFI (T&D).

### **III. Submission of System Reliability Metrics for October 2025**

In further compliance with the Energy Bureau’s May 16 Order, LUMA hereby submits the October 2025 System SAIDI (T&D FYTD), System Monthly SAIDI (T&D), System SAIFI (T&D FYTD), and System Monthly SAIFI (T&D) metrics data. This submission is accompanied by the Excel workbook entitled “*Resumen Métricas Máster\_November2025.xlsx*” (“Exhibit 1”), which contains the required reliability metrics in accordance with the directives outlined in the

<sup>2</sup> In a *Resolution and Order* of August 18, 2022, this Energy Bureau granted LUMA’s request to align the quarterly filings of system data in this proceeding with the filing of the quarterly operation report submitted after each quarter of the fiscal year closes. Consequently, the quarterly reports are now due in the following months: October (with data for the months of July through September), January (with data for the months of October through December), April (with data for the months of January through March), and July (with data for the months of April through June). See *Request for Modification of Schedule to File System Data and Submission of Quarterly Performance Metrics Report for June 2022* (“Request to Modify Schedule”) and Exhibit 1 (Schedule of proposed changes) and Exhibit 2 (Proposed Filing Schedule).

May 16 Order. *See* Exhibit 1, cells BF136, BF137, BF140, and BF141. LUMA respectfully notes that the values reported for October 2025 are preliminary and, as such, remain subject to revision in future submissions as needed.

**WHEREFORE**, LUMA respectfully requests that this Honorable Bureau **take notice of** the aforementioned; **accept** the monthly report on system reliability metrics for October 2025.
