**RESOLUTION AND ORDER**

**I. Introduction**

On April 28, 2025, Accurate Solutions Corp. ("Accurate") submitted a Request for Certification Electric Power Companies ("Request for Certification") before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") with several forms, annexes and information, including the following:

1. *Request for Certification Electric Power Companies* (Form NEPR-B04).

- a. Certified statement that, under Section 3.03(A)(3) of Regulation 8701, the electric service company has sufficient financial resources to operate and provide the services it intends to offer. The statement is duly signed by a certified public accountant (CPA).
- b. Certified statement that, under Section 3.03(A)(4) of Regulation 8701, the company has the necessary human resources (technical, professional, and administrative) to operate and provide the services it intends to offer in Puerto Rico.

Annex 1 - List of the personnel working in actual projects, and certificates of technical training.

Annex 2 - List of facilities, location, equipment specifications and kind of service offered.

- a. Certificate of Incorporation Stock Corporation issued on June 25, 2015, by the Puerto Rico Department of State.
- b. Certificate of Registration issued on June 25, 2015, by the Puerto Rico Department of State.

- d. Merchant Registration Certificate issued on April 25, 2025, by the Puerto Rico Treasury Department.

3. *Gross Revenue and Financial Statements Electric Power Companies* (Form NEPR-B05).

- a. Interim Financial Statements as of March 31, 2025, and from June 1, 2024, to March 31, 2025.

4. Annex 1 including the following documents:

- a. Capabilities & Qualifications Summary, July 2025.
- b. Personnel Certifications.

5. Annex 2 includes the following document:

- a. Description of Distributed Generation Systems.

6. Annex 3 includes the following documents:



- a. Municipal License<sup>1</sup> issued for July 1, 2025, to June 30, 2026, by Mayagüez Municipality.
- b. Merchant Registration Certificate issued on April 25, 2025, by the Puerto Rico Treasury Department.
- c. Copy of an email from the Puerto Rico Department of Economic Development and Commerce to Accurate, dated January 30, 2025, requesting certain information and documents related to an application under Act 60-2019,<sup>2</sup> including copy of Certification issued by the Puerto Rico Energy Bureau.

On July 14, 2025, the Energy Bureau issued a Resolution and Order (“July 14 Resolution”) determining that the Request for Certification was incomplete and granted Accurate thirty (30) days to submit the information and documentation to demonstrate compliance with the applicable provisions. Specifically, the Energy Bureau listed fifteen (15) elements missing in the Request for Certification.<sup>3</sup>

On August 7, 2025, Accurate filed a document (“August 7 Motion”) titled “Reconsideration” In the August 7 Motion, Accurate reported that: (i) the Request for Certification was submitted as part of the evaluation of its services to be provided, in order to qualify for a tax exemption decree under Act 60-2019; (ii) the tax benefits under Act 60-2019 don’t require Accurate to be active in the market; (iii) the energy sales services under the PPA model have not yet commenced, and (iv) the actual distributed generation renewable energy systems and high-efficiency combined heat and power (CHP) systems mentioned in the Request for Certification were designed, operated and maintained under contracts without energy sales and were mentioned for reference.

Through the August 7 Motion, Accurate submitted its reply to each of the required elements listed as missing by the Energy Bureau in the July 14 Resolution. Accurate requests to be certified by the Energy Bureau provided that each future location where it establishes operation will require an update of the case with the elements indicated in the July 14 Resolution.

**II. Applicable Laws and Regulations**

*A. Regulation 8701 requirements regarding Request for Certification*

Section 3.01(A)(1) of Regulation 8701 requires that the request for certification shall detail the type or types of electric service the company intends to offer. In cases where the company offers electric power generation or transmission services, it must establish the company’s aggregate capacity.

Section 3.03(A)(2) of Regulation 8701 requires that the request for certification shall detail whether the electric service company **intends** to enter a contract or any other legal transaction with PREPA or any other electric service company for the provision of service. If this were the case, it must specify the type of legal transaction it intends to enter into, the objective of the legal transaction, and the name of the electric service company with which it intends to enter into the legal transaction.

Section 3.03(B)(1)(c)(ii)(e) of Regulation 8701 requires that the request for certification must include the information of the area of Puerto Rico to be affected by the service the company intends to provide, identifying the municipalities, neighborhoods, and sectors within said space.

Section 3.03(A)(4) of Regulation 8701 requires that the request for certification must include a statement as to the fact that the company has human resources (technical, professional, and administrative) to operate and provide the services it intends to offer in Puerto Rico. The company must also list in detail the technical and professional qualifications of the personnel, as well as the profile of those it intends to recruit to show their expertise and competence to operate and provide the services the company intends to offer in Puerto Rico.

Section 3.03(A)(5) requires that the request for certification must include a copy of the permits, authorizations, and federal, state, and municipal endorsements the company has obtained to: (i) operate and do business in Puerto Rico; and (ii) provide electric power service in Puerto Rico.

Section 3.03(B) of Regulation 8701 requires that the request for certification must include certain information regarding the facilities, equipment and services for the generation of energy.

Section 3.07 of Regulation 8701 requires that companies must submit evidence of payment of filing fee for its request for certification. Notwithstanding, under Section 3.07(B) the company may request that the Energy Bureau waive the requirement to pay the fee for the submission of the Operational Report if it is onerous under its circumstances.

#### *B. Regulation 8701 requirements related to Operational Report*

Regulation 8701 requires that for Energy Storage the following information must be in the operational report:

 Section 2.02(A)(3)(a) - A projection of the capital investments it will make within a three (3) year time horizon, including investments for the acquisition or use of equipment, technologies, systems, and facilities.

 Section 2.02(A)(3)(b) - All reports the company has or has prepared regarding improvements in the behavior of the electric system as it pertains to the location of the storage unit.

 Section 3.03(B)(1) - Certain information about the facilities, equipment and services for electric service companies that offer electric power storage.

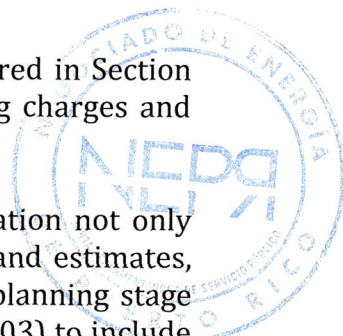
Section 2.02(C) of Regulation 8701 requires the following:

Electric service companies that intend to operate or offer services in Puerto Rico after this Amendment has taken effect must submit the appropriate Operational Report under Subsection (A) of this Section, along with their Request for Certification.

The operational report to be submitted must include the information required in Section 2.02, including the information required by Section 2.02(A)(1)(b) regarding charges and rates.

Section 2.02 of Regulation 8701 requires in the operational report information not only about operations being carried out but also information about projections and estimates, that is, forward-looking information. Even companies with projects in the planning stage must submit an *Operational Report Electric Service Companies* (Form NEPR-B03) to include the available information and indicate N/A in the rest of the form that doesn't apply or is not yet available.

 Under Section of 2.03(A)(2) of Regulation 8701 electric service companies must submit evidence of payment of filing fee for its operational report. Notwithstanding, under Section 2.03(B) the company may request that the Energy Bureau waive the requirement to pay the fee for the submission of the Operational Report if it is onerous under its circumstances.



III. Conclusion

Upon review of the August 7 Motion, the Energy Bureau **DETERMINES** Accurate’s Request for Certification is **INCOMPLETE**. As such, the Energy Bureau **GRANTS** Accurate **thirty (30) additional days** from the notification of this Resolution and Order **to submit the outstanding information and documentation described below**, including an *Operational Report Electric Power Companies* (Form NEPR-B03) with the corresponding annexes and evidence of payment of the corresponding filing fee for the *Request of Certification Electric Service Companies* (Form NEPR-B04), *Personal Information Electric Service Companies* (Form NEPR-B01) and *Operational Report Electric Service Companies* (Form NEPR-B03).

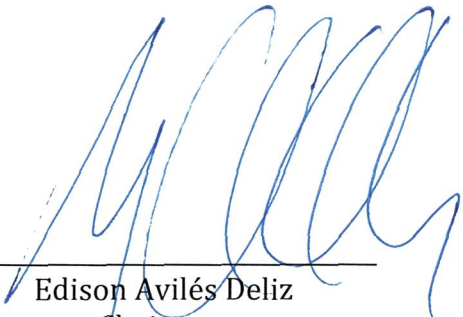

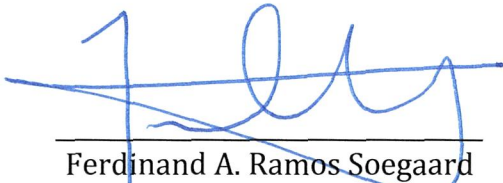

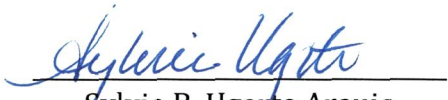
