SUBJECT: Request for Information regarding the status of renewable energy projects.

RESOLUTION AND ORDER

I. Introduction and Procedural Background

On June 12, 2025, Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("June 12 Order"), through which it ordered LUMA¹ and the Puerto Rico Electric Power Authority ("PREPA") to prioritize and facilitate the advancement of renewable energy and energy storage projects resulting from Tranche 1, 2 and 4², as well as legacy renewable energy projects³ that were most advanced in their development stage and most shovel-ready.

On June 17, 2025, PREPA submitted a document titled *Motion in Compliance with Resolution and Order issued on June 12, 2025* ("June 17 Motion"), through which PREPA included several exhibits (Exhibits A, B, C and D) with materials and updated information regarding the status of renewable energy and energy storage projects from Tranches 1, 2, and 4, the status of legacy renewable energy projects, and the status of the PPOA amendments requested by developers, among other requested information.

II. Discussion and Conclusion

The June 12 Order emphasized the urgency of completing these projects given the critical need to add new capacity to support Puerto Rico's electric system reliability and to capitalize on a narrow window of opportunity for new project investment with federal funding. The Energy Bureau included guidance with specific criteria to facilitate which projects should be advanced in their development.

There are multiple renewable energy and storage projects at different contractual and/or development stages. Delays in the execution of these projects do not align with the best public interest for the people of Puerto Rico nor with PREPA customers, who deserve a reliable and safe service in compliance with Act 82-2010⁴.

The Energy Bureau **ORDERS** PREPA to file, **on or before Thursday January 15, 2026**, the following:

- (i) An updated table with the status of the PPOA and/or ESSA amendments requested to PREPA by developers of Tranches 1, 2, and 4, and the legacy renewable energy projects.
- (ii) Copies of the foregoing requests received from developers.
- (iii) Copies of any draft PPOA and/or ESSA amendments prepared related to the developers' requests.
- (iv) Most recent project status submitted by developers of tranches 1, 2 and 4.
- (v) Detailed project schedule in Project Gannt Chart or similar format by developers of Tranches 1, 2, and 4, and the legacy renewable energy projects.

The Energy Bureau **WARNS** PREPA that failure to comply with this Resolution and Order will result in the imposition of fines under Section 6.36 of Act 57-2014.⁵
