SUBJECT: Resolution and Order regarding Motion in Compliance with Resolution and Order Granting Certification, filed by Sol Ecolution Puerto Rico LLC.

RESOLUTION AND ORDER

On November 25, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("November 25 Resolution"), whereby it determined that Sol Ecolution Puerto Rico LLC ("Sol Ecolution") had not corrected certain deficiencies in order to comply with Regulation 8863.1 Particularly, the informal and formal procedures for bill objection were not stated in a clear manner in Sol Ecolution's model bill. Moreover, the hyperlink to Sol Ecolution's website did not direct the user to a publication describing such procedures. Instead, the hyperlink directed customers to Regulation 8863. Therefore, the Energy Bureau provided as a reference, a summary of the referenced procedures and a model bill, both included as Annex A to the November 25 Resolution, and ordered Sol Ecolution to revise its website and model bill in accordance with the foregoing.

On December 2, 2025, Sol Ecolution filed a document titled Motion in Compliance with Resolution and Order Granting Certification ("December 2 Motion"). Through the December 2 Motion, Sol Ecolution indicated it had made additional revisions to its invoice and website incorporating the procedure for bill objections following the reference provided by the Energy Bureau and attached as Exhibit 1 a revised version of its model bill.

The Energy Bureau DETERMINES that Sol Ecolution PARTIALLY COMPLIED with the November 25 Resolution. Although Sol Ecolution filed a model invoice describing the informal and formal procedures for bill objection as ordered, the hyperlink does not direct the user to a publication describing such procedures. The hyperlink still directs customers exclusively to Regulation 8863. Although a link to Regulation 8863 may be provided, a detailed summary of the procedures as outlined in Annex A to the November 25 Resolution and Sol Ecolution's model bill, must also be included the website.

The Energy Bureau **GRANTS** Sol Ecolution ten (10) days to provide a detailed summary of the objection procedure via Sol Ecolution's link. The Energy Bureau WARNS Sol Ecolution that failure to comply will result in the imposition of fines under Art. 6.36 of Act 57-2014.²
