of Time to Comply with the December 19
Order and Submit Quarterly Report on
System Data for October through
December 2025**

**MOTION REQUESTING EXTENSION OF TIME TO COMPLY WITH THE
DECEMBER 19 ORDER AND SUBMIT QUARTERLY REPORT ON SYSTEM DATA
FOR OCTOBER THROUGH DECEMBER 2025**

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW, LUMA ENERGY SERVCO, LLC ("LUMA"), through the undersigned legal counsel and respectfully states and requests the following:

1. On December 19, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order addressing various matters related to performance metrics reporting and directing the parties to comply with additional requirements as part of the metrics reporting ("December 19 Order"). Specifically, the Energy Bureau ordered LUMA and Genera to submit the underlying data and supporting workpapers for the metrics listed in Attachment A for fiscal year 2025 ("FY2025") and to continue reporting such data and workpapers at the frequency (annually or quarterly) specified therein. The Energy Bureau further directed LUMA to submit the FY2025 underlying data and supporting workpapers within thirty (30) days of the December 19 Order, *i.e.*, by January 19, 2026.

2. LUMA respectfully brings to the Energy Bureau's attention that the Quarterly Report on System Data for October through December 2025 is due on January 20, 2026. LUMA submits that it would be procedurally efficient and practical to consolidate these reporting obligations into a

single submission that includes both (i) the FY2025 data and supporting workpapers required by the December 19 Order and (ii) the quarterly performance metrics for the second quarter of FY2026.

3. Accordingly, LUMA respectfully requests that the Energy Bureau authorize LUMA to file one consolidated submission encompassing both requirements. Furthermore, given the intervening holiday period between the issuance of the December 19 Order and the current deadlines of January 19 and January 20, 2026, LUMA requests an extension until January 27, 2026, to complete this consolidated filing. This brief extension will allow LUMA to align internal reporting and recordkeeping processes with the new requirements, ensuring accuracy and full compliance with the December 19 Order while integrating these obligations into existing procedures.

4. This request is made in good faith, without intent to delay proceedings, and solely to ensure complete compliance with the Energy Bureau's directives. Granting this extension will not prejudice any party nor impair the Energy Bureau's regulatory oversight.

WHEREFORE, LUMA respectfully requests that this Honorable Energy Bureau grant LUMA's request to (1) consolidate the December 19 Order's FY2025 data and supporting workpapers submission with the quarterly performance metrics report for October through December 2025; and (2) extend the deadline for this consolidated submission to January 27, 2026.
