SUBJECT: LUMA's Request for Extension of Time to Comply with the December 19 Order and Submit Quarterly Report on System Data for October through December 2025

RESOLUTION AND ORDER

On December 29, 2025, LUMA ENERGY SERVCO, LLC ("LUMA") filed a document titled *Motion Requesting Extension of Time to Comply with the December 19 Order and Submit Quarterly Report on System Data for October through December 2025* ("Request") before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau"). In the Request, LUMA asks for an extension of time to submit its response to the requirements of the Resolution and Order issued on December 19, 2025 ("December 19 Order") as well as its Quarterly Report on System Data for October through December 2025. According to LUMA, this extension of time will allow LUMA to consolidate two separate submissions into a single submission encompassing both requirements. LUMA highlights that this would be procedurally efficient and also account for the holiday period that occurred after the issuance of the December 19 Order. LUMA also notes that the extension will allow LUMA to align internal reporting and recordkeeping processes with the new requirements.


Upon review of the Request, the Energy Bureau **GRANTS** LUMA until January 27, 2026, to submit its Quarterly Report as well as its response to the December 19 Order, which directed LUMA and Genera to file additional supporting data and workpapers for the metrics included in Attachment A of the December 19 Order.

The Energy Bureau also **EXTENDS** the deadline for Genera PR LLC ("Genera") to file its Quarterly Report and additional supporting data and workpapers for the metrics included in Attachment A of the December 19 Order to January 27, 2026. The other deadlines established in the December 19 Order remain unchanged.
