**MOTION REQUESTING ADDITIONAL TIME TO FILE STATUS UPDATE**

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW Global Power Solutions (PR) LLC ("Global Power"), through the undersigned legal counsel, and respectfully states and prays:

1. On October 21, 2025, the Puerto Rico Energy Bureau ("Energy Bureau") issued a Resolution and Order (the "October 21 Resolution"), in which it determined, among other things, that certain documents and information required for Global Power's Electrical Service Company Certification Request ("Request for Certification") remained pending.<sup>1</sup> The Energy Bureau granted a thirty (30)-day period, from the notification of the October 21 Resolution for Global Power to provide an update on the status of the Agreement for the sale of electrical power to the Puerto Rico Electric Power Authority ("PREPA") and to submit other outstanding documentation.
2. The October 21 Resolution explicitly deferred several certification requirements, including the filing fee balance of \$1,200 for the Request for Certification, certified financial statements, and permits, until the formalization of the Agreement.<sup>2</sup>

3. On November 20, 2025, Global Power filed a *Motion in Compliance with the Resolution and Order of October 21, 2025*, (“November 2025 Motion”) informing the Energy Bureau that, as of that date, the Agreement had not yet been executed and requesting additional time to provide a subsequent status update and address outstanding documentation.

4. On November 24, 2025, the Energy Bureau issued a Resolution and Order granting Global Power a sixty (60)-day extension, that is, until January 19, 2026, to provide its next status update regarding execution of the Agreement and compliance with the outstanding documentation. Because January 19, 2026 is a federal and local holiday in observance of Martin Luther King Jr. Day, on which the offices of the Energy Bureau are closed, the applicable deadline is extended to the next business day, January 20, 2026, pursuant to Section 1.09 of *Amendment to Regulation No. 8618 on Certification, Annual Fees, and Operational Plans for Electric Service Companies in Puerto Rico*, dated February 17, 2016.

5. As discussed in the November 2025 Motion, the Agreement referenced in the docket arises from the emergency temporary power generation procurement process initiated in March 2025, under which PREPA, through the Third-Party Procurement Office (“3PPO”), issued Request for Proposals No. 3PPO-0314-20-TPG, subsequently reissued on July 15, 2025 as RFP No. 3PPO-0314-20-TPG2 (“Procurement Process”). The Agreement forms a critical component of Global Power’s anticipated operations as a certified Electric Service Company and is subject to approvals from PREPA, the Energy Bureau, and the Financial Oversight and Management Board.

6. As of the date of this Motion, the Agreement has not been executed. Global Power remains ready to continue engaging with relevant parties to address the technical, contractual, and regulatory matters required for execution and approval of the Agreement.

7. Global Power notes that a separate administrative proceeding is currently pending before this Honorable Energy Bureau in Case No. NEPR-MI-2024-0005, involving a *Motion to Vacate the Resolution and Order dated December 11, 2025*, which challenges the conditional approval

of a power generation contract between PREPA and Power Expectations LLC resulting from the Procurement Process. The resolution of that challenge could materially impact the execution of the Agreement or otherwise alter the terms, obligations, and timing associated therewith; consequently, it may dictate the necessary scope and content of Global Power's subsequent status updates.

8. In light of the continued multi-agency review and approval process, the express deferral of several certification requirements pending execution of the Agreement, and the pendency of related administrative proceedings that may affect the Agreement's execution, Global Power respectfully submits that additional time beyond the sixty (60)-day extension already granted is necessary to allow the process to advance in an orderly manner and to provide a meaningful and comprehensive status update based on the most current and final information available.

Accordingly, Global Power respectfully requests an additional ninety (90)-day extension, counted from January 20, 2026, to submit its next status update regarding execution of the Agreement and compliance with the outstanding documentation.

WHEREFORE, Global Power Solutions (PR) LLC respectfully requests this Honorable Energy Bureau to (1) TAKE NOTICE that, as of the date of this Motion, the Agreement has not been executed; and (2) GRANT Global Power an additional extension for a ninety (90)-day extension, counted from January 20, 2026, to file the subsequent status update regarding execution of the Agreement and compliance with the outstanding documentation.
