**RESOLUTION AND ORDER**

On January 16, 2026, Enernet CHP TWO, LLC ("Enernet Two") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Informative Motion, Request for Waiver and Request for Confidential Treatment* ("January 16 Motion"), submitting redacted and unredacted versions of the Motion and the following attachments:

1. Attachment I - *Operational Report Electric Power Companies* (Form NEPR-B03).
2. Supplemental Attachment I - Annexes to *Operational Report Electric Power Companies* (Form NEPR-B03).
3. Attachment II - *Gross Revenue and Financial Statements Report* (NEPR-B05).
4. Supplemental Attachment II - Annex to *Gross Revenue Gross Revenue and Financial Statements Report* (Form NEPR-B05).

Enernet Two requested confidential treatment of the January 16 Motion and the attached documents by the justifications detailed in the Motion.

Enernet Two requested that the filing fee payment for its *Operational Report* be waived by the Energy Bureau by reason that it would be onerous according to Section 2.03(D) of Regulation 8701<sup>1</sup> due to operational reasons reported in the January 16 Motion.

Upon reviewing the January 16 Motion and attached documents filed by Enernet Two, the Energy Bureau **TAKES NOTICE** of the filing of its *Operational Report Electric Power Companies* (Form NEPR-B03) in compliance with Section 2.02 of Regulation 8701 and the filing of its *Gross Revenue and Financial Statements Report* (NEPR-B05) in compliance with Section 4.02 of Regulation 8701.


The Energy Bureau **DETERMINES** Enernet Two **COMPLIED** with Section 2.03(B) of Regulation 8701, setting forth the facts and legal basis why the payment of the filing fee would be onerous, and **WAIVES** the filing fee for its 2025 *Operational Report for Electric Power Companies* (Form NEPR-B03).<sup>2</sup>

The Energy Bureau **GRANTS** confidential designation and treatment to the January 16 Motion and the attached documents, and **TAKES NOTICE** Enernet Two filed a public redacted version of the referenced documents in accordance with Section 6.15 of Act 57-2014<sup>3</sup>; Section 1.15 of Regulation 8701; and *In Re: Policy on Management of Confidential Information*


