SUBJECT: Resolution and Order pertaining to *Motion Requesting Additional Time to File Status Update*, filed by Global Power Solutions (PR) LLC.

RESOLUTION AND ORDER

On November 24, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("November 24 Resolution") granting Global Power Solutions (PR) LLC ("Global") a sixty (60) day extension to provide the next status update regarding its participation in an emergency temporary power generation process for the procurement of 800 MW under which PREPA issued request for proposals.

On January 20, 2026, Global filed a document titled *Motion Requesting Additional Time to File Status Update* ("January 20 Motion"), whereby it reported that the execution of the agreement for its participation has not been executed due to certain technical, contractual, and regulatory matters. Global requested an additional ninety (90) day extension, counted from the date of the filing of the January 20 Motion, to file the subsequent status update regarding execution of the agreement and compliance with the corresponding documentation.

The Energy Bureau **TAKES NOTICE** of the information presented by Global Power in the January 20 Motion and **GRANTS** the requested **ninety (90) day extension** to provide the next status update. Nevertheless, the Energy Bureau **ORDERS** Global Power to report any relevant information on the status of the Agreement that arises during the ninety (90) day period.


