SUBJECT: Resolution and Order regarding *Motion in Compliance with January 15, 2026 Resolution, Request for Extension, and Request for Guidance* filed by SunStrong Management, LLC.

RESOLUTION AND ORDER

On January 20, 2026, SunStrong Management, LLC ("SunStrong") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion in Compliance with January 15, 2026 Resolution, Request for Extension, and Request for Guidance* ("January 20 Motion"). In the January 20 Motion, SunStrong reported that it was in the process of implementing certain enhancements to its customer complaint procedure under Section 6.03 of Regulation 9246¹; in compliance with the December 3, 2025, and January 15, 2026, Resolutions issued by the Energy Bureau requesting additional detail and clarity. SunStrong stated that the enhancements are intended to provide additional transparency, structure, and clarity to customers while maintaining full consistency with the regulatory framework already in place. SunStrong requested a sixty (60) day extension to finalize and publish the updated complaint procedure and informed that it will continue to operate under the previous complaint procedure in place while developing the necessary new elements.

The Energy Bureau **GRANTS** SunStrong **thirty (30) days**, from the notification of this Resolution, to submit its consumer complaint procedure as well as evidence of its publication.

The Energy Bureau **WARNS** SunStrong that failure to comply with this Resolution and Order will result in the imposition of fines in accordance with Section 6.36 of Act 57-2014.²


