**RESOLUTION AND ORDER**

On April 28, 2024, Accurate Solutions Corp. ("Accurate") submitted a Request for Certification as an Electric Power Company ("Request for Certification") before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") with several forms, annexes, and information.

On July 14, 2025, the Energy Bureau issued a Resolution and Order ("July 14 Resolution") determining that the Request for Certification was incomplete and granted Accurate thirty (30) days to file all necessary information and documentation required to demonstrate compliance with the applicable provisions, to enable the proper evaluation of the Request for Certification.

On August 7, 2025, Accurate filed a document ("August 7 Motion") titled "Reconsideration" in response to the July 14 Resolution submitting certain information.

On November 24, 2025, the Energy Bureau issued a Resolution and Order ("November 24 Resolution") granting Accurate thirty (30) days to submit certain information and documentation described in the Resolution, including: (i) an *Operational Report Electric Power Companies* (Form NEPR-B03) with the corresponding annexes; (ii) evidence of payment of the corresponding filing fee for the *Request of Certification Electric Service Companies* (Form NEPR-B04); (iii) evidence of payment of the corresponding filing fee for *Personal Information Electric Service Companies* (Form NEPR-B01); and (iv) evidence of payment of the corresponding filing fee for *Operational Report Electric Service Companies* (Form NEPR-B03). The Energy Bureau warned Accurate that failure to submit the referenced information would result in deeming the request for certification as not filed.

The deadline to comply with the November 24 Resolution expired on December 29, 2025. Accurate failed to appear before the Energy Bureau.

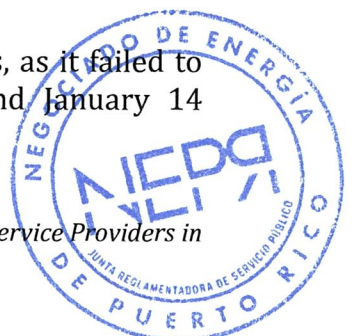
On January 14, 2026, the Energy Bureau issued a Resolution and Order granting Accurate fifteen (15) additional days to submit the requested information. The Energy Bureau reiterated that failure to submit the referenced information would result in deeming the request for certification as not filed.

The deadline to comply with the January 14 Resolution was January 29, 2025. Accurate has failed to comply with the Energy Bureau's requirements.

As stated in Art 3.03(G) of Regulation 8701<sup>1</sup>, Requests for Certification shall be deemed submitted if the appropriate fee has been paid, they contain all the information, data, and documents required by Regulation 8701, and once the Energy Bureau has confirmed and given written notice that this Request is complete. **Any Requests that do not comply with every applicable provision of Regulation 8701 shall be deemed to have never been submitted and shall no legal effect.**

Accurate has shown no interest in continuing with the certification process, as it failed to appear before the Energy Bureau in response to the November 24 and January 14 Resolutions.

In light of the above, the Energy Bureau **DEEMS** the April 28 Submission as not filed and **ORDERS** its Clerk to close and archive this case for administrative purposes.
