**SUBJECT:** Request for extension to comply  
with January 23, 2026, Resolution and Order

**MOTION REQUESTING EXTENSION OF TIME TO COMPLY WITH JANUARY 23, 2026,  
RESOLUTION AND ORDER**

**COMES NOW** the Puerto Rico Electric Power Authority ("PREPA"), through its  
counsel of record, and respectfully submits and requests as follows:

1. On January 23, 2026, the Puerto Rico Energy Bureau ("Energy  
Bureau") issued a Resolution and Order ("Resolution"), ordering PREPA and LUMA  
Energy LLC ("LUMA") to take several actions regarding the Energy Efficiency  
("EE") Rider funds. Specifically, relevant to this motion, PREPA was ordered to  
respond to several detailed requirements of information ("ROIs") regarding EE  
Rider fund transfers, within ten (10) business days of the notification of the  
Resolution, which responses are due tomorrow, February 6.

2. PREPA has been diligently working on: (i) preparing and  
simultaneously evaluating its responses to the ROIs; and (ii) gathering and  
reviewing the communications and supporting documentation required by the  
Resolution. Given the scope, detail, and historical nature of the information  
requested, PREPA's review remains ongoing.

3. To complete this endeavor and submit accurate and complete  
responses, PREPA respectfully requests a brief extension of seven (7) business days,  
to run from February 6, 2026.

4. This request is made in good faith and not for purposes of unnecessary delay. The requested extension is narrowly tailored and necessary to ensure that PREPA's responses are complete and consistent with the Resolution, thereby promoting an orderly and efficient review by the Energy Bureau.

**WHEREFORE**, PREPA respectfully requests the Energy Bureau to take **NOTICE** of the Motion and **GRANT** PREPA the extension of time of seven (7) business days to comply with the Resolution.
