
SUBJECT: Resolution and Order on Request
of Extension of Time

RESOLUTION AND ORDER


On February 9, 2026, the Puerto Rico Electric Power Authority (“PREPA”) filed a document titled *Motion for Extension of Time to File Reply on Revenue Requirement and Rate Design Briefs* (“February 9 Request”), in which PREPA alleges that following the conclusion of the evidentiary hearings, PREPA has identified areas of concern regarding aspects of the case and the reasoning reflected in specific decisions issued during the course of the proceeding.¹ PREPA alleges that these concerns arise at a threshold level and may affect further merits briefing on revenue requirements or rate design by any party. PREPA alleges it will file a separate brief articulating such concerns.² PREPA requests an extension to all parties to file the Reply Briefs on Revenue Requirement and the Initial Brief on Rate Design to February 16, 2026. PREPA alleges this would allow the Energy Bureau time to review PREPA’s filing of its legal concerns.³

PREPA has filed its extension request on the day of the deadline for the reply brief on the Revenue Requirement and on the day before the deadline for the initial briefs on rate design. This untimely filing is based on PREPA’s alleged legal concerns that may affect the merits of future briefs which PREPA shall file before February 16, 2026, extension request. The Energy Bureau of the Puerto Rico Public Service Regulatory Board (“Energy Bureau”) **GRANTS** the requested extension and **ORDERS** PREPA to file its legal concerns no later than Wednesday, February 11, 2026, by 4:00 p.m.


