**MOTION SUBMITTING ADJUSTED VEGETATION MANAGEMENT  
PROGRESS REPORT FOR THE FIRST QUARTER OF FISCAL YEAR 2026**

**TO THE PUERTO RICO ENERGY BUREAU:**

COME NOW LUMA Energy, LLC, and LUMA Energy ServCo, LLC, (jointly referred to as “LUMA”), through the undersigned legal counsel, respectfully submits the following:

1. On November 14, 2025, LUMA submitted to the Puerto Rico Energy Bureau (“Energy Bureau”) its *Motion Submitting Vegetation Management Progress Report for the First Quarter of Fiscal Year 2026* (“November 14<sup>th</sup> Motion”).<sup>1</sup> **Exhibit 1** to the November 14<sup>th</sup> Motion is the Vegetation Management Progress Report for the First Quarter of Fiscal Year 2026 (“VMP Report for Q1 FY2026”).<sup>2</sup>

2. During the preparation of the Vegetation Management Progress Report for the Second Quarter of Fiscal Year 2026, a review of prior-period data identified an inadvertent discrepancy in the supporting documents used to draft the VMP Report for Q1 FY2026.

<sup>1</sup> Pursuant to the Energy Bureau’s Resolution and Order issued on August 8, 2024 (“August 8<sup>th</sup> Order”) in the *In Re: LUMA Initial Budgets and Related Terms of Service*, Case No. NEPR-MI-2021-0004 (“Initial Budgets Docket”), LUMA must file quarterly Vegetation Management Progress reports using a template determined by the Energy Bureau. The progress reports are due 45 days after the end of each quarter and must be filed in the instant proceeding.

Specifically, the Federally Funded clearing miles reported on the “Summary” tab did not align with the “Circuit Miles Maintained / Cleared” column on the “Distribution Lines” tab. While the “Summary” tab correctly reflected 141 miles cleared using federal funds, the “Distribution Lines” tab inadvertently reported only 51 miles. Upon correcting the “Circuit Miles Maintained/Cleared” on the “Distribution Lines” tab to reflect the accurate total, the associated number of poles was also updated accordingly.

3. LUMA hereby submits an Adjusted Vegetation Management Progress Report for the First Quarter of Fiscal Year 2026 (“Adjusted Vegetation Management Progress Report”) correcting the discrepancy described above. *See Exhibit A* to this Motion.

4. The purpose of this motion is to inform the Energy Bureau of the discrepancy found and to provide an adjusted report that addresses the discrepancy and provides a new footnote to the “Summary” tab clarifying some of the type of work on the federally funded miles and acres.

**WHEREFORE**, LUMA respectfully requests that the Energy Bureau **take notice** of the aforementioned; **replace** the VMP Report for Q1 FY2026 submitted as **Exhibit 1** to the November 14<sup>th</sup> Motion with the Adjusted Vegetation Management Progress Report attached to the present motion (*Exhibit A*); **incorporate** this Motion and its *Exhibit A* onto the online public docket; and **deem** LUMA in compliance with the August 8<sup>th</sup> Order.
