RESOLUTION AND ORDER

On July 12, 2024, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution ("July 12 Resolution") through which it modified the submission schedule of the interconnection progress reports and compliance hearings as requested by LUMA Energy ServCo, LLC and LUMA Energy, LLC (collectively "LUMA"). The Energy Bureau scheduled the Compliance Hearings up to the *Q4 2025 Progress Report* (i.e., February 23, 2026 @ 10am).

On January 27, 2026, LUMA filed a motion titled *Motion Requesting Order Granting Leave to Proceed with Revised Presentation Template*. Though this Motion LUMA requested a continuance of the compliance hearing scheduled for February 23, 2026. LUMA stated that Mr. Charles Tweten, a key witness, whose participation is essential to ensure a complete and informative presentation to the Energy Bureau and the public would not be available. LUMA requested the hearing be rescheduled to a date within the week of March 9-13, 2026.

On February 13, 2026, LUMA filed a motion titled *Motion Submitting Interconnection Progress Report for October-December 2025 and Requesting Order for Continuance of Hearing*. Through this Motion LUMA renewed its previous request for continuance.

Through this Resolution and Order the Energy Bureau **TAKES NOTICE** of LUMA's January 27, 2026 and February 13, 2026 Motions, accepts all submissions attached to the said Motions and **RESCHEDULES** the next Compliance Hearing for **Thursday, March 12, 2026 at 10:00 am**. The Energy Bureau will discuss LUMA's request to modify the report during the next Compliance Hearing. The Energy Bureau **CLARIFIES** that it will not require LUMA to file any updated reports at this time.

For the Compliance Hearing, as previously established by the Energy Bureau, LUMA **SHALL**: (i) provide all relevant representatives with all pertinent documents for the compliance hearings; (ii) make sure said representatives be ready to answer questions that the Energy Bureau staff and/or Commissioners may have; and (iii) timely file a copy of any Power Point presentation, visuals or materials that LUMA intends to use during the Compliance Hearings.




