**RESOLUTION AND ORDER**

On February 4, 2026, Sonnel Power Solutions LLC ("Sonnel") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Informative Motion and Request for Extension of Time* ("February 4 Motion") requesting an extension of time until May 4, 2026, to submit certain information as originally requested by the Energy Bureau in its June 18, 2026 Resolution and Order regarding Sonnel's Petitions<sup>1</sup> filed on May 15, 2025.

In the February 4 Motion, Sonnel reported the status a project under consideration by the Puerto Rico Department of Housing CDBG-DR/MIT Electrical Power Reliability and Resilience Program ("PRDOH/ER2 Program"). Sonnel indicated that it has continued working diligently to secure the approvals and confirmations necessary to finalize the project's final specifications and submitting additional information requested. It was also reported PRDOH/ER2's review remains ongoing, including plans for in-person meetings with Sonnel's team.

Sonnel requested an extension until May 4, 2026, to allow the PRDOH/ER2 to complete its review and for Sonnell to prepare and submit the necessary amendments and remaining documentation to complete its Petition.

After reviewing the February 4 Motion, the Energy Bureau **GRANTS** Sonnel until **May 4, 2026** to provide the referenced information.


