**MOTION TO REQUEST CONFIDENTIAL  
TREATMENT OF GROSS REVENUE REPORT**

**TO THE HONORABLE ENERGY BUREAU:**

**COMES NOW**, Palmetto Solar LLC (“Palmetto”), represented by the undersigned legal counsel, and respectfully submits the following:

1. Section 4.02(B) of the *Amendment to Regulation No. 8618 on Certification, Annual Fees, and Operational Plans for Electric Service Companies in Puerto Rico, Regulation 8701 of the 17th of February 2016*, as amended (“Regulation 8701”) mandates all electric service companies operating in Puerto Rico to whom the Honorable Energy Bureau has issued a Certification to inform the Energy Bureau of their annual gross revenue within a period of sixty (60) days following the conclusion of the natural year.
2. Palmetto hereby complies with Section 4.02(B) of Regulation 8701 by informing the Honorable Energy Bureau of its gross revenues for fiscal year 2025 and submitting the Gross Revenue and Financial Statements Form NEPR-B05 (**Attachment 1**).
3. Palmetto requests that confidential treatment be afforded to this motion and its corresponding attachment. Section 6.15 of Act No. 57 of May 17, 2014, as amended, 22 LPRA § 1054n, provides:

## Confidential Treatment Requested

If any person who is required to submit information to the Energy [Bureau] believes that the information to be submitted has any confidentiality privilege, such person may request the [Bureau] to treat such information as such, subject to the following:

(a) If the Energy [Bureau], after the appropriate evaluation, believes such information should be protected, it shall grant such protection in a manner that least affects the public interest, transparency, and the rights of the parties involved in the administrative procedure in which the allegedly confidential document is submitted.

(b) To such purposes, the Energy [Bureau] shall provide access to the document or the privileged portion of the document only to the lawyers and external consultants involved in the administrative process after the execution of a confidentiality agreement.

(c) The Energy [Bureau] shall keep the documents submitted for its consideration out of public reach only in exceptional cases. In these cases, the information shall be duly safeguarded and delivered exclusively to the personnel of the Energy [Bureau] who needs to know such information under nondisclosure agreements. However, the Energy [Bureau] shall direct that a non-confidential copy be furnished for public review.

(d) The Energy [Bureau] shall swiftly act on any privilege and confidentiality claim made by a person subject to its jurisdiction by means of a resolution to such purposes before any allegedly confidential information is disclosed.

4. Palmetto respectfully requests that all the information contained in this motion and attached hereto be kept confidential in accordance with Section 1.15 of Regulation 8701. In compliance with the process to designate confidential information, Palmetto hereby includes redacted versions of the documents for which confidential treatment is sought (**Attachment 1**). These documents have sensitive information, otherwise not available to the public, which Palmetto prefers not to disclose and that could place Palmetto at a competitive disadvantage. Moreover, Table 1 below contains a list of all the documents including information for which confidential treatment is requested.

**WHEREFORE**, Palmetto Solar LLC respectfully requests that the Honorable Bureau declare Palmetto in compliance with Section 4.02(B); take notice of the redacted version of the documents for which it requests confidentiality and the table numbering each redaction request and its justification; and grant confidential treatment to the document attached hereto.
