SUBJECT: Order to Show Cause regarding
Gross Revenue Report.

ORDER TO SHOW CAUSE

Section 4.02 of Regulation 8701¹ requires all electric service companies to inform their annual gross revenue within a period of sixty (60) days following the conclusion of their natural year. Pursuant to the applicable regulation, the deadline to submit such report was **March 3, 2026**. As of the date of this Order, the required report has not been filed.

The Energy Bureau of the Puerto Rico Public Service Regulatory Board (“Energy Bureau”) **ORDERS** Xzerta Tec Solar I, LLC (“Xzerta”) to **SHOW CAUSE**, within **ten (10) days** from the notification of this Order, as to why the Bureau should not impose an administrative fine of **\$10,000** pursuant to Article 6.36 of Act 57-2014² for failure to comply with the Energy Bureau’s regulatory requirements.

The Energy Bureau further **ORDERS** Xzerta to submit its Gross Revenue Report within the same **ten (10) day** timeframe.






