**ORDER TO SHOW CAUSE**

Section 2.02 of Regulation 8701<sup>1</sup> requires all electric service companies, providing the services described in Section 2.02(A)(1), (2), (3), (4) and (5), to file an annual operational report on or before the month of March of each year. Pursuant to the applicable regulation, the deadline to submit such report was **March 31, 2026**. As of the date of this Order, the required report has not been filed.


The Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") **ORDERS** Rooftop Solar JV LLC ("Rooftop Solar") to **SHOW CAUSE**, within **ten (10) days** from the notification of this Order, as to why the Energy Bureau should not impose an administrative fine of **\$10,000** pursuant to Article 6.36 of Act 57-2014<sup>2</sup> for failure to comply with the Energy Bureau's regulatory requirements.


The Energy Bureau further **ORDERS** Rooftop Solar to submit its Operational Report Electric Services Companies (Form NEPR-B03) within the same **ten (10) day** timeframe.

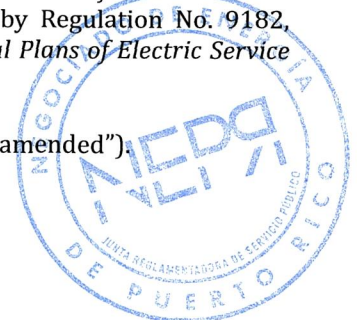
