Motion to Request Extension of Time

TO THE HONORABLE ENERGY BUREAU:

COMES NOW CEN Juncos Solar II, LLC (“Juncos Solar II”), represented by the undersigned legal counsel, and very respectfully prays and requests:

1. Section 4.02(E) of the Amendment to Regulation No. 8618 on Certification, Annual Fees, and Operational Plans for Electric Service Companies in Puerto Rico, Regulation 8701 of the 17th of February 2016, (“Regulation 8701”) (as amended by Regulation No. 9182) requires electrical service companies whose gross revenues are equal to or less than three million dollars (\$3,000,000.00), to file compiled financial statements, within 120 days of the end of an electrical service company’s fiscal year, that must be signed by an authorized representative of the electric service company. The signature of the authorized representative shall constitute a sworn certification, under penalty of perjury, that said information is correct and complete. The financial statements can be compiled by a Certified Public Accountant (CPA) authorized to practice said profession in Puerto Rico or any other jurisdiction in the United States of America. CEN Juncos Solar II, LLC’s fiscal year ended on December 31.

2. Juncos Solar II respectfully notifies the Honorable Energy Bureau that the compiling for fiscal year 2025 (“FY2025”) is ongoing. Juncos Solar II has commissioned an accounting firm, BEUSSINK, HEY & ROE, P.C., to formally prepare its FY2025 financial disclosure, which includes attaching compiled financial statements in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA.

3. Due to the ongoing busy season that causes a heavy workload at BEUSSINK, HEY & ROE, P.C. and in accordance with Section 5.01 of Regulation 8701, we kindly request a sixty (60) day extension for the submission of the compiled financial statements to the Honorable Energy bureau. Juncos Solar II assures the Honorable Energy Bureau of its commitment to prioritize and complete this requirement promptly thereafter.

WHEREFORE, CEN Juncos Solar II, LLC respectfully requests that the Energy Bureau grant it until June 29, 2026, to file its fiscal year 2025 financial compiled statements, and comply with section 4.02(E) of Regulation 8701 (as amended by Regulation No. 9182)
