**ORDER TO SHOW CAUSE**

On May 7, 2026, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("May 7 Order") granting Windmar Renewable Energy, Inc. ("Windmar") ten (10) days to submit the unredacted confidential version of its FY 2025 Financial Statements for the Energy Bureau's review, as required by Section 4.02 of Regulation 8701<sup>1</sup>. The deadline to submit such financial statements was May 18, 2026. As of the date of this Order, the required document has not been filed.


Confidentiality can be granted to financial statements upon request to protect financial information from public disclosure. Nevertheless, it can't impair the regulatory authority over regulated entities or undermine the protection of the public interest.


The Energy Bureau **ORDERS** Windmar to **SHOW CAUSE** within **ten (10) days** from the notification of this Order, as to why the Energy Bureau should not impose an administrative fine of \$10,000 pursuant to Article 6.36 of Act 57-2014<sup>2</sup> for failure to comply with the Energy regulatory requirements.

The Energy Bureau further **ORDERS** Windmar to submit the confidential version of its FY 2025 Financial Statements within the same **ten (10) day** timeframe.
