**SUBMISSION OF MONTHLY REPORT ON SYSTEM
RELIABILITY METRICS FOR JULY 2026**

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW, LUMA ENERGY SERVCO, LLC (“LUMA”), through the undersigned legal counsel and respectfully states and requests the following:

I. Introduction

LUMA respectfully submits this motion in compliance with the Puerto Rico Energy Bureau’s (“Energy Bureau”) directives regarding the reporting of system reliability metrics. This filing provides the required data for July 2026, pursuant to the Energy Bureau’s order entered on May 16, 2025, and in accordance with the applicable provisions of the *Puerto Rico Transmission and Distribution System Operation and Maintenance Agreement* and prior orders in this proceeding.

II. Relevant Procedural Background

The requirement to submit quarterly reports on specified system data of the Puerto Rico Electric Power Authority (“PREPA”) arises under the *Resolution and Order* issued by the Energy Bureau on May 14, 2019, in this proceeding. Following the *Resolution and Order* issued on December 30, 2020, the quarterly system data is due on the 20th day of the month after each quarter closes.

According to Section 5.6 of the T&D OMA, LUMA, as an agent of PREPA, submits systems data regarding the Transmission and Distribution System (“T&D System”).

On May 16, 2025, the Puerto Rico Energy Bureau issued a *Resolution and Order* with the subject *Response to LUMA's January 15 Motion, Response to Genera's February 3 and February 10 Motions, System Reliability Metric Reporting Frequency, and Additional System Reliability Metrics* (the “May 16 Order”). The Energy Bureau directed LUMA to begin reporting by the 20th day of the following month, *inter alia*, the reliability metrics outlined in Section C(a), to wit: System SAIDI (T&D FYTD), System Monthly SAIDI (T&D), System SAIFI (T&D FYTD) and System Monthly SAIFI (T&D).

III. Submission of System Reliability Metrics for July 2026

In further compliance with the Energy Bureau’s May 16 Order, LUMA hereby submits the July 2026 System SAIDI (T&D FYTD), System Monthly SAIDI (T&D), System SAIFI (T&D FYTD), and System Monthly SAIFI (T&D) metrics data. This submission is accompanied by the Excel workbook entitled “*Resumen Métricas Máster_August2026.xlsx*” (**Exhibit 1**), which contains the required reliability metrics in accordance with the directives outlined in the May 16 Order. *See* Exhibit 1, cells BO136, BO140, BO143 and BO147. LUMA respectfully notes that the values reported for July 2026 are preliminary and, as such, remain subject to revision in future submissions as warranted.

WHEREFORE, LUMA respectfully requests that this Honorable Bureau **take notice of** the aforementioned and **accept** the monthly report on system reliability metrics for July 2026.
